

**PEE DEE ACADEMY**  
**2020-2021 -Tuition Contract**  
**Kindergarten 3 – 4 – 5 (Circle One)**

Kindergarten hours are from 8:00 a.m. until 2 p.m.

This application is subject to the following conditions:

1. Pay \$4,560.00 per student. This includes all general activity fees.  
Also, each new student enrolling must pay a one time, non-refundable building assessment fee of \$250.00 due at time of registration. 2nd/\$200.00, 3rd/\$150.00
2. Payment Option-Please check one: (Payment must be made before registration is complete)  
\_\_\_\_\_ A. Payment in full of \$4,560.00 per student for the school year - due with contract on 4/30/20.  
\_\_\_\_\_ B. 12 equal monthly payments - the first payment of \$380.00 per month is due with the contract by 4/30/20. Subsequent payments of \$380.00 per month are due beginning 6/01/20 and ending 4/01/21  
\_\_\_\_\_ C. DRAFT–No payment necessary, stay on same schedule. Return signed contract.

**Note:** If you paid a waiting list deposit, your \$100.00 deposit will be applied to your first payment unless you have other children on the waiting list.

3. This contract is binding upon the parents for the full and complete sum from the date of the execution of this contract. Any monthly payment not received by Pee Dee Academy by the 14th of each month will receive a 5% late fee. Any student who has a delinquent payment of more than two months is subject to dismissal from Pee Dee Academy and Pee Dee Academy shall have the right to declare the entire balance due immediately. In the event that Pee Dee Academy declares the entire balance due immediately, Pee Dee Academy shall have the right to collect from the parents all costs and expenses incurred in enforcing this agreement, including, but not limited to, reasonable attorneys' fees. A student will not receive Kindergarten credit, participate in graduation exercises, or continue in school after spring registration until all financial obligations are current and complete.

4. Late Registration:

New Students: A new student enrolling after contracts are due or after the school year has begun is responsible for the following Tuition Charges: Tuition is the full amount if enrollment is in June, July, August or September, 2/3 in October, November, or December, 1/2 in January or February, and 1/3 in March, April, or May. Current students who register after contracts are due must pay the following late fees:

<u>AFTER MAY 1, 2020</u>	- \$50.00 per child
<u>AFTER JUNE 1, 2020</u>	- \$100.00 per child
<u>AFTER JUNE 30, 2020</u>	- the student is considered a new student and must pay \$250.00 for new enrollment

5. This contract is binding upon the parents for the full and complete amount from the date of the execution of this contract unless:
  - A. The student is required to move to another city where such distance makes attendance impractical.
  - B. The student has a long term illness of such severity that attendance would be injurious and harmful to the student.
  - C. There are other extenuating circumstances that the Board of Directors of Pee Dee Academy deem sufficient enough to justify releasing the parents from the remaining balance of the contract.
  
6. During the academic year of this contract, if a student is expelled or withdraws from Pee Dee Academy for any reason not stated in number 5 of this contract, then the parents of the student are responsible for fulfilling the entire financial obligation of this contract and Pee Dee Academy has the right to declare the entire balance due immediately.
 

As stated in number 3 of this contract, if Pee Dee Academy declares the entire balance due immediately, Pee Dee Academy shall have the right to collect from the parents all costs and expenses incurred in enforcing this agreement, including, but not limited to reasonable attorneys' fees. A student will not receive Kindergarten credit, participate in graduation exercises, or continue in school after spring registration until all financial obligations are current and complete.
  
7. Pee Dee Academy reserves the right to refuse any applicant admission under the guidelines adopted by its Board of Directors and to determine to which class each applicant will be assigned.
  
8. Expulsion- Students at Pee Dee Academy are subject to all rules and regulations contained in the current PDA Handbook. Pee Dee Academy reserves the right to expel any student for any scholastic or disciplinary action, either on or off campus, that brings discredit to the reputation of Pee Dee Academy. The affected student and parents of such student shall be notified prior to any action and shall be given the opportunity to present to the Board of Directors any mitigating factors which they might deem pertinent in a called board meeting. Any student who is expelled is subject to the conditions stated in number 6 of this contract.
  
9. Pee Dee Academy reserves the right not to renew this contract should the student's behavior or academic performances fall below an acceptable standard as determined by the Academy's administration and Board of Directors.
  
10. This contract is non-transferable and shall not be binding upon Pee Dee Academy until it is executed by its Chairman of the Board of Directors.
